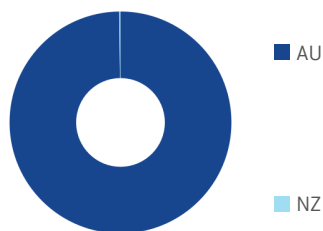

COUNTRY WEIGHTINGS EXCL. OFFSHORE*



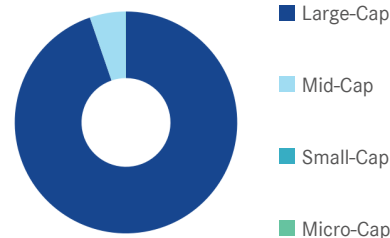

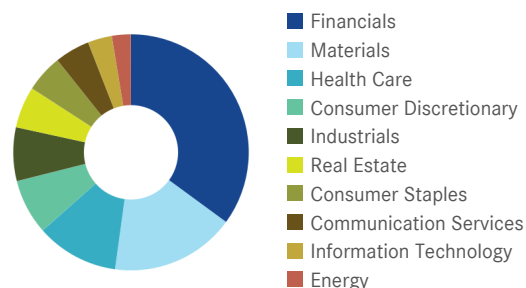
